## **I. INTRODUCTION**

The Sanjo College of Nursing and Allied Sciences, Vellappara, Palakkad is a Catholic Christian educational institution established and managed by the Diocesan Charitable Trust of the Syro Malabar Diocese of Palakkad. College is situated just 50 meters away from Thrissur-Coimbatore National Highway and just 10 Kms from Palakkad Town. Sanjo College of Nursing and Allied Sciences has an annual in-take of **60 students** for B.Sc. Nursing. The college is approved by **INC (Indian Nursing Council)**, **KNMC (Kerala Nursing and Midwifery Council)** and is affiliated to **KUHS (Kerala University of Health Sciences)**.

The Nursing College is the 3<sup>rd</sup> institution under the Sanjo Group of Educational Institutions at Vellappara. Sanjo College of Pharmaceutical Studies and Sanjo Central School are the other institutions at Vellappara Campus. #### **Overview of the B.Sc. Nursing Course**

- Our college offer B.Sc. Nursing Degree Programme of 4year duration as specified by Kerala University of Health Sciences, (KUHS), approved by Indian Nursing Council & Kerala Nurses and Midwives Council.

## **II. ELIGIBILITY FOR ADMISSION**

### **Academic:**

- (i) Candidates who have passed Higher Secondary Examination of the Board of Higher Secondary Education of Kerala or equivalent examinations recognized by the State of Kerala with Aggregate of 50 % marks in Physics, Chemistry, Biology in second year and 50 % marks in English in second year only are eligible for admission.

**(ii) Eligibility Certificates:** Candidates who have passed their qualifying examination from places other than State of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from KUHS, Thrissur. This should be furnished at the time of interview for admission.

**(iii) Age:**

- (i) Age: Applicants should have completed 17 years of age as on the 31st December 2024. No Relaxation in the minimum age will be allowed. The upper age limit for candidates for B.Sc Nursing is 35 years as on 31.12.2024.
- (ii) Self-attested copy of relevant page of school record namely SSLC/ICSE/CBSE/ certificate showing the date of birth / copy of birth certificate should be produced at the time of admission.

### **III. HOW TO APPLY**

Application for admission to B.Sc. Nursing course can be registered online with application fee Rs. 1200 through website [www.sanjocollegeofnursing.org](http://www.sanjocollegeofnursing.org). Submission of more than one application by a candidate will lead to rejection of the application for the same course submitted subsequent to the first application. The printout of the application form should be submitted together with all the necessary documents

### **STEPS TO SUBMIT THE APPLICATION**

- (i) Candidate shall visit [www.sanjocollegeofnursing.org](http://www.sanjocollegeofnursing.org) click the link “Admissions”.
- (ii) Fill the online application form.
- (iii) Filled application form with photo, signature and required documents shall be submitted online.

### **IV. SELECTION OF CANDIDATES**

**(i) Management Seat:**

50% seats will be filled by management from the applications received by the college on the basis of merit. The merit list will be based on the marks obtained in the qualifying examination in the core subjects as mentioned in the eligibility criteria. 10% weightage will be given to CBSE, ICSE and AISSCE after normalization.

**(ii) Resolution of Tie While Ranking**

In the case of a tie in the total marks, the marks in Biology will be counted. If there is still a tie the marks in Chemistry and Physics will be counted. If a tie still exists, the age of the candidate will be taken into account, the elder will be preferred.

**(iii) Validity of the Merit list:**

The published merit list will be valid till the date upto which the merit list shall be kept alive in terms of instruction/direction of Admission Supervisory Committee/competent authority.



Inclusion in the merit list will not guarantee admission to the course, unless the applicant satisfies the conditions as laid down in the Prospectus. –

Furnishing of false information/particulars would result in the forfeiture of the candidature as well as Cancellation of admission to the course and in addition will attract the relevant provisions of criminal law of the land.

## V. ADMISSION & PAYMENT OF FEES

- The selected candidates will be informed about the date and time of admission through mail.

Candidates who express their intention not to pursue studies in the Nursing College before the last date fixed for closure of admissions will be eligible for refund of the 1<sup>st</sup> year tuition fee and other fees except admission fee. They will be eligible to get back their original certificates handed over to the College at the time of admission. In the case of students who leave the college midway, the right of the management for liquidated damages, if any, from such students will be determined by the competent “Civil Court.”

## VI. SPECIAL INSTRUCTIONS

(i) **Ragging:** Ragging in any form is strictly prohibited in college. College is committed to abolish ragging in the campus. Hence any student who indulges in any form of ragging will be subjected to penal action as per provisions of law. Also, the student will be expelled from the college as detailed in the law concerned and as per Honorable Supreme Court of India directions in this regard. Anti Ragging Committee and anti-ragging squad will take effective measures against ragging. It will effectively monitor and comply with the directions in the institution. Each of the student and his/her parent/guardian are required to submit a combined undertaking at the time of registration/admission.
